INVESTMENT OBJECTIVE AND STRATEGY

The Chinabank Cash Fund intends to achieve a high level of liquidity and better earnings potential than those offered by regular savings deposit accounts and money market placements by investing in a diversified portfolio of deposits with a weighted average portfolio modified duration of not more than one (1) year. The Fund aims to outperform its benchmark which is the Bloomberg Philippine Sovereign Bond Index Money Market (BPHILMM Index).

CLIENT SUITABILITY

A client profiling process shall be performed prior to participating in the Fund to guide the prospective investor if the Fund is suited to his/her investment objectives and risk tolerance. Before deciding to invest, clients are advised to read the Declaration of Trust, a copy of which is available at the Trustee's principal office.

The Chinabank Cash Fund is suitable only for investors who:

- have a conservative risk appetite;
- are looking for a cash parking facility offering acceptable returns; and
- have an investment horizon of one (1) year or less.

KEY RISKS AND RISK MANAGEMENT

The client should not invest in this Fund if the client does not understand or is not comfortable with the accompanying risks.

- **Interest Rate Risk.** This is the possibility for an investor to experience losses due to changes in interest rates. The purchase and sale of a debt instrument may result in profit or loss because the value of a debt instrument changes inversely with prevailing interest rates.

Regulatory exposure limits as well as the Fund's average duration are monitored regularly to ensure that exposures are managed. The Fund also employs risk management measures to monitor significant declines in the Fund's NAVPu and alert the Trustee to review current strategies and take corrective action as necessary. The Fund also undergoes an annual review to ensure that it is equipped to fund any redemption requirement in a timely manner and at a reasonable cost during times of financial stress.



NAVPU GRAPH





The BPHILMM Index is a systematically designed, rules-based, market value-weighted index that measures the performance of short-term, fixed-rate and zero-coupon local currency securities that are publicly issued by the Philippines. It includes liquid money market instruments such as treasury bills with maturities of less than 1 year and minimum par amounts of Php3.0Bn. This Index is adjusted for tax by the Trustee, but does not reflect deductions for fees and expenses. Additional information on the benchmark and/or its administrator can be found on Bloomberg, and be made available to investors upon request.

The benchmark provides a reference for evaluating the performance of highly liquid, peso-denominated money market instruments with a similar investment horizon to the Fund.

RELATED PARTY TRANSACTIONS

The Fund has deposits with the Bank Proper, amounting to Php981.58 million, which were approved by the Board of Directors/Trust Investment Committee. Likewise, all related parties transactions are conducted on an arm's length basis.

OUTLOOK AND STRATEGY

In January, the peso yield curve bull-steepened as weak gross domestic product (GDP) growth supported expectations of further monetary easing. Yields on average fell by 10 basis points (bps), with the short-end outperforming the rest of the curve. Rates for 1 year and below fell by 17 bps with the 1-year rate falling by 20 bps to 4.8412%. The belly declined by 14 bps, with the 2-year rate fetching 5.1883%, down 18 bps, while the long-end was up 4bps driven by ultra long tenors, as the 10-year rate fell 9 bps to 5.9868%. Trading volume for the month increased by 54% to Php1.672 trillion, with RTBs accounting for majority or 43% of volume, followed by FXTNs at 30%.

Economic data last month continued to support the case for further monetary easing. GDP rose 3.0% in 4Q, bringing full-year 2025 growth to 4.4%, reflecting soft domestic demand, weaker investment activity, and construction delays linked to governance issues.

²**Volatility** measures the degree to which the Fund fluctuates vis-à-vis its average return over a period of time. This is computed by getting the standard deviation of the yearly returns for the past 12 mos.

³**Sharpe Ratio** is used to characterize how well the return of a Fund compensates the investor for the level of risk taken. The higher the number, the better. This is computed by dividing the excess return of the fund against the risk-free rate over the fund's volatility.

⁴**Information Ratio** measures the reward-to-risk efficiency of the portfolio relative to the benchmark. The higher the number, the higher the reward per unit of risk. This is computed by dividing the excess return of the fund against the benchmark over the fund's volatility.

Consumption and capital formation also moderated, though analysts expect growth to improve as reforms and project execution stabilize. Overseas remittances as of November softened month-on-month as holiday and typhoon-related transfers were front-loaded. Still, inflows reached USD2.91B, up 3.6% year-on-year, keeping remittances a steady FX anchor and lifting year-to-date cash remittances to USD32.11B. Meanwhile, inflation edged up to 1.8% in December, driven by food supply disruptions and holiday demand, partly offset by slower declines in rice prices. Inflation is expected to remain manageable despite slight base-effect pressure in 2026. Lastly, unemployment rose to 4.4% in November following typhoon damage, though holiday-season hiring should provide a temporary lift, with continued labor-market resilience anticipated into 2026.

In the primary market, the Bureau of the Treasury (BTr) raised Php176.6 billion in bonds and Php147.6 billion in bills in its weekly auctions. The auctions continued to be well-received by the market with bid-to-cover ratios averaging 3.41x for the bills and 2.38x for the bonds despite rates for the bond auctions averaging an uptick of 10 bps versus previous auctions. Looking ahead, the market will take its cue from key macroeconomic data heading into the BSP rate-setting meeting in February where a cut is widely expected. With this, the Fund continues to invest in a combination of various time deposits to optimize returns while managing liquidity.

INVESTMENT POLICY / PROSPECTIVE INVESTMENTS

The Fund may be invested or reinvested in the following:

- a) Deposits with local banks, including those of the Trustee’s own bank;
- b) Deposits with foreign banks or their Philippine branches or any financial institution in any foreign country; and
- c) Such other tradable investment outlets/categories as the Bangko Sentral ng Pilipinas (BSP) may allow.
