### INVESTMENT OBJECTIVE AND STRATEGY

The Chinabank Cash Fund intends to achieve a high level of liquidity and better earnings potential than those offered by regular savings deposit accounts and money market placements by investing in a diversified portfolio of deposits with a weighted average portfolio modified duration of not more than one (1) year. The Fund aims to outperform its benchmark which is the Bloomberg Philippine Sovereign Bond Index Money Market (BPHILMM Index).

#### **CLIENT SUITABILITY**

A client profiling process shall be performed prior to participating in the Fund to guide the prospective investor if the Fund is suited to his/her investment objectives and risk tolerance. Before deciding to invest, clients are advised to read the Declaration of Trust, a copy of which is available at the Trustee's principal office.

## The Chinabank Cash Fund is suitable only for investors who:

- have a conservative risk appetite;
- are looking for a cash parking facility offering acceptable returns; and
- have an investment horizon of one (1) year or less.



The Fund also employs risk management measures to monitor significant declines in the Fund's NAVPu and alert the Trustee to review current strategies and take corrective action as necessary. The Fund also undergoes an annual review to ensure that it is equipped to fund any redemption requirement in a timely manner and at a reasonable cost during times of financial stress.

The BPHILMM Index is a systematically designed, rules-based, market value-weighted index that measures the performance of short-term, fixed-rate and zero-coupon local currency securities that are publicly issued by the Philippines. It includes liquid money market instruments such as treasury bills with maturities of less than 1 year and minimum par amounts of Php3.0Bn. This Index is adjusted for tax by the Trustee, but does not reflect deductions for fees and expenses. Additional information on the benchmark and/or its administrator can be found on Bloomberg, and be made available to investors upon request.

The benchmark provides a reference for evaluating the performance of highly liquid, peso-denominated money market instruments with a similar investment horizon to the Fund.

<sup>3</sup>Sharpe Ratio is used to characterize how well the return of a Fund compensates the investor for the level of risk taken. The higher the number, the better. This is computed by dividing the excess return of the fund against the riskfree rate over the fund's volatility.

<sup>4</sup>Information Ratio measures the reward-to-risk efficiency of the portfolio relative to the benchmark. The higher the number, the higher the reward per unit of risk. This is computed by dividing the excess return of the fund against the benchmark over the fund's volatility.

### **RELATED PARTY TRANSACTIONS**

The Fund has deposits with the Bank Proper, amounting to Php921.27 million, which were approved by the Board of Directors/Trust Investment Committee. Likewise, all related parties transactions are conducted on an arm's length basis.

# **OUTLOOK AND STRATEGY**

In June, the peso yield curve slightly bear-flattened as geopolitical risks raised inflation concerns, but was tempered by the central bank's dovish stance amid low inflation and weak growth. Yields across the curve rose by an average of 2 basis points (bps), with the belly rising the most at 3 bps. Meanwhile, short-end rates increased by 2 bps on average and the long-end held steady. Trading volume for the month fell by 20.7% to Php1.034 trillion, which was comprised largely by FXTNs at 29%, followed by Bangko Sentral ng Pilipinas

Philippine inflation cooled further in May, declining to 1.3% from April's 1.4%, in line with the BSP's projected range of 0.9% to 1.7%. This deceleration was largely due to reduced costs in housing, utilities, and fuel, along with a sharper drop in transportation prices. Core inflation held steady at 2.2% for the third consecutive month, while the average inflation rate for the year slipped to 1.9%. Amidst the favorable inflation trend and weaker-than-anticipated first-quarter economic growth, the BSP cut its benchmark interest rate by 25 bps to 5.25% at its recent policy meeting. The central bank also hinted at the possibility of additional rate cuts if inflationary pressures continue to remain subdued, despite ongoing global uncertainties.

In the primary market, the Bureau of the Treasury (BTr) auctioned off Php135.282 billion worth of bonds and Php132.45 billion worth of bills for the month. Both offerings saw strong demand, with bid-to-cover ratios averaging 1.73x for bonds and 3.19x for bills. T-bill rates rose by an average of 2 bps versus the previous month, while rates for the bonds, which had tenors of 3, 5, 7, 10, and 25 years, increased by 8 bps on average versus previous auctions. Additionally, the BTr also released its Q3 bond borrowing program, totaling Php365 billion, which is lower Q2's program of Php410 billion. We expect the market to be on watch for rate movements brought by the upcoming auctions, as well as key macroeconomic data including inflation. With this, the Fund maintains a diversified mix of time deposits to optimize both liquidity and yield.

## **INVESTMENT POLICY / PROSPECTIVE INVESTMENTS**

The Fund may be invested or reinvested in the following:

- a) Deposits with local banks, including those of the Trustee's own bank;
- b) Deposits with foreign banks or their Philippine branches or any financial institution in any foreign country; and
- c) Such other tradable investment outlets/categories as the Bangko Sentral ng Pilipinas (BSP) may allow.
