## INVESTMENT OBJECTIVE AND STRATEGY

The Chinabank Dollar Cash Fund intends to achieve liquidity and to potentially earn higher than USD time deposits by investing in fixed income securities of mostly time deposits, special savings accounts and government securities with a weighted average portfolio modified duration of not more than one (1) year. The Fund aims to outperform its benchmark which is the Bloomberg US Treasury Bills 3-6 Months Index.

## **CLIENT SUITABILITY**

A client profiling process shall be performed prior to participating in the Fund to guide the prospective investor if the Fund is suited to his/her investment objectives and risk tolerance. Before deciding to invest, clients are advised to read the Declaration of Trust, a copy of which is available at the Trustee's principal office.

## The Chinabank Dollar Cash Fund is suitable only for investors who:

- have a conservative risk appetite;
- are seeking a high level of liquidity with returns better than deposits; and,
- have an investment horizon of one (1) year or less.

## KEY RISKS AND RISK MANAGEMENT

The client should not invest in this Fund if the client does not understand or is not comfortable with the accompanying risks.

- Interest Rate Risk. This is the possibility for an investor to experience losses due to changes in interest rates. The purchase and sale of a debt instrument may result in profit or loss because the value of a debt instrument changes inversely with prevailing interest





<sup>2</sup>**Volatility** measures the degree to which the Fund fluctuates vis-à-vis its average return over a period of time. This is computed by getting the standard deviation of the yearly returns for the past 12 mos.

<sup>3</sup>Sharpe Ratio is used to characterize how well the return of a Fund compensates the investor for the level of risk taken. The higher the number, the better. This is computed by dividing the excess return of the fund against the risk-free rate over the fund's volatility.

<sup>4</sup>Information Ratio measures the reward-to-risk efficiency of the portfolio relative to the benchmark. The higher the number, the higher the reward per unit of risk. This is computed by dividing the excess return of the fund against the benchmark over the fund's volatility.

#### **RELATED PARTY TRANSACTIONS**

The Fund has deposits with the Bank Proper, amounting to USD5.18 million, which were approved by the Board of Directors/Trust Investment Committee. Likewise, all related parties transactions are conducted on an arm's length basis.

## **OUTLOOK AND STRATEGY**

In April, the US dollar yield curve bull-steepened, as lower-than-expected inflation data renewed expectations for policy rate cuts. Benchmark rates declined by an average of 9 basis points (bps), led by a 25-bp drop in the belly of the curve. The short end slipped 3 bps, while the long end edged up 2 bps. The 2s10s spread widened to 57 bps from 34 bps in March, with the 2-year yield falling 29 bps to 3.6% and the 10-year yield down 6 bps to 4.17%. Meanwhile, ROPs tracked the move in US Treasuries, declining by 10 bps on average.

March inflation surprised to the downside, with headline consumer price index (CPI) easing to 0.1% month-on-month, largely due to a 6.3% drop in gasoline prices and continued weakness in used vehicles. Year-on-year, CPI rose 2.4%, down from 2.8% in February. Similarly, the producer price index (PPI) fell 0.4% month-on-month, slowing annually to 2.7% from 3.2% in the previous month. These inflation prints, coupled with dovish signals from the US Federal Reserve's (Fed) March minutes, reinforced expectations for rate cuts of up to 100 bps by year-end, with some anticipating the first cut as early as June. However, renewed US tariff threats on Chinese goods revived inflationary and recession fears.

Other macroeconomic data came out mixed. The S&P Global Flash US Manufacturing PMI fell to 49.9 in April, signaling contraction and hitting a four-month low. In contrast, new home sales rose 8.8%, driven by lower prices, but existing home sales remained weak due to limited inventory. As for the jobs market, initial jobless claims rose slightly to 222,000, though continuing claims fell to 1.84 million, indicating still-tight labor conditions. Meanwhile, consumer sentiment plunged to 50.8, its second-lowest on record, amid growing concerns about inflation and tariffs. Looking ahead, markets will watch key data including Q1 GDP, inflation, and jobs reports, as well as developments on US trade policies. With this, the Fund remains focused on managing liquidity and enhancing returns through selective time deposit placements.

## **INVESTMENT POLICY / PROSPECTIVE INVESTMENTS**

The Fund may be invested or reinvested in the following:

- a) Deposits with local banks, including those of the Trustee's own bank;
- b) Deposits with foreign banks or their Philippine branches or any financial institution in any foreign country; and
- c) Such other tradable investment outlets/categories as the Bangko Sentral ng Pilipinas (BSP) may allow.
