INVESTMENT OBJECTIVE AND STRATEGY

The Chinabank Dollar Cash Fund intends to achieve liquidity and to potentially earn higher than USD time deposits by investing in fixed income securities of mostly time deposits, special savings accounts and government securities with a weighted average portfolio modified duration of not more than one (1) year. The Fund aims to outperform its benchmark which is the Bloomberg US Treasury Bills 3-6 Months Index.

CLIENT SUITABILITY

A client profiling process shall be performed prior to participating in the Fund to guide the prospective investor if the Fund is suited to his/her investment objectives and risk tolerance. Before deciding to invest, clients are advised to read the Declaration of Trust, a copy of which is available at the Trustee's principal office.

The Chinabank Dollar Cash Fund is suitable only for investors who:

- have a conservative risk appetite;
- are seeking a high level of liquidity with returns better than deposits; and,
- have an investment horizon of one (1) year or less.

KEY RISKS AND RISK MANAGEMENT

The client should not invest in this Fund if the client does not understand or is not comfortable with the accompanying risks.

- **Interest Rate Risk.** This is the possibility for an investor to experience losses due to changes in interest rates. The purchase and sale of a debt instrument may result in profit or loss because the value of a debt instrument changes inversely with prevailing interest.
- **Liquidity Risk.** This is the possibility for an investor to experience losses due to the inability to sell or convert assets into cash immediately or in instances where conversion to cash is possible but at a loss. Regulatory exposure limits as well as the Fund's average duration are monitored regularly to ensure that exposures are managed. The Fund also undergoes an annual review to ensure that it is equipped to fund any redemption requirement in a timely manner and at a reasonable cost during times of financial stress.



NAVPU GRAPH





²Volatility measures the degree to which the Fund fluctuates vis-à-vis its average return over a period of time. This is computed by getting the standard deviation of the yearly returns for the past 12 mos.

³Sharpe Ratio is used to characterize how well the return of a Fund compensates the investor for the level of risk taken. The higher the number, the better. This is computed by dividing the excess return of the fund against the risk-free rate over the fund's volatility.

⁴Information Ratio measures the reward-to-risk efficiency of the portfolio relative to the benchmark. The higher the number, the higher the reward per unit of risk. This is computed by dividing the excess return of the fund against the benchmark over the fund's volatility.

RELATED PARTY TRANSACTIONS

The Fund has deposits with the Bank Proper, amounting to USD4.90 million, which were approved by the Board of Directors/Trust Investment Committee. Likewise, all related parties transactions are conducted on an arm's length basis.

OUTLOOK AND STRATEGY

In January, the dollar yield curve held steady amid a combination of lower-than-expected economic growth and inflation, and strong labor data. Benchmark US yields fell by just 0.3 basis points (bps) on average, with the belly outperforming, falling by 2 bps. The 2-year rate was down 3 bps to 4.22%. Meanwhile the long-end underperformed, rising by 2bps on average, with the 10-year rate flat at 4.58%. The benchmark 2-year versus 10-year spread widened to 0.36 versus December's 0.30. The short-end meanwhile fell by 1 bp on average, with the 1-year rate up 1 bp to 4.17%.

A key driver for the market in January was US core inflation coming out slower than expected. December's core consumer price index, which excludes food and energy, stood at 0.2% month-on-month. This was lower than the market-expected 0.3% and was driven by slower gains in core commodities, new and used vehicles, apparel and medical services. Meanwhile, the job market surprised as nonfarm payrolls came out stronger-than-expected at 256k in December, beating market estimates. The unemployment rate also declined to 4.1% from 4.2%.

In light of the within-target inflation and robust labor market data, the Federal Reserve (Fed) decided to hold interest rates steady, in line with expectations. Officials have adopted a wait-and-see approach amid uncertainties surrounding President Trump's fiscal and trade policies, which could potentially drive inflation higher. In post-meeting statements, the Fed highlighted the resilience of the U.S. economy and a labor market that is gradually normalizing, posing some upside risks to inflation and justifying the decision to pause.

Later in the month, the Q4 2024 gross domestic product (GDP) growth rate came out at 2.5% year-on-year, bringing full-year growth to 2.8% in 2024. The Q4 growth fell short of the 2.6% consensus estimate and was slower than the 3.1% growth recorded in the previous quarter. Consumer expenditures remained a key driver, highlighting the resilience of household demand despite prevailing inflationary pressures.

Looking ahead, the market will take its cue from key macroeconomic data including inflation, PMI and jobs report. Market will also be on watch of developing news of potentially market-moving policies of President Trump. In view of this, the Fund continues to be remains strategic in acquiring time deposits to optimize returns while ensuring liquidity is effectively managed in alignment with its objectives.

INVESTMENT POLICY / PROSPECTIVE INVESTMENTS

The Fund may be invested or reinvested in the following:

- a) Deposits with local banks, including those of the Trustee's own bank;
- b) Deposits with foreign banks or their Philippine branches or any financial institution in any foreign country; and
- c) Such other tradable investment outlets/categories as the Bangko Sentral ng Pilipinas (BSP) may allow.
