INVESTMENT OBJECTIVE AND STRATEGY

The Chinabank Dollar Cash Fund intends to achieve liquidity and to potentially earn higher than USD time deposits by investing in fixed income securities of mostly time deposits, special savings accounts and government securities with a weighted average portfolio modified duration of not more than one (1) year. The Fund aims to outperform its benchmark which is the Bloomberg US Treasury Bills 3-6 Months Index

CLIENT SUITABILITY

A client profiling process shall be performed prior to participating in the Fund to guide the prospective investor if the Fund is suited to his/her investment objectives and risk tolerance. Before deciding to invest, clients are advised to read the Declaration of Trust, a copy of which is available at the Trustee's principal office.

The Chinabank Dollar Cash Fund is suitable only for investors who:

- have a conservative risk appetite;
- are seeking a high level of liquidity with returns better than deposits; and,
- have an investment horizon of one (1) year or less.

KEY RISKS AND RISK MANAGEMENT



²Volatility measures the degree to which the Fund fluctuates vis-à-vis its average return over a period of time. This is computed by getting the standard deviation of the yearly returns for the past 12 mos.

³Sharpe Ratio is used to characterize how well the return of a Fund compensates the investor for the level of risk taken. The higher the number, the better. This is computed by dividing the excess return of the fund against the risk-free rate over the fund's volatility.

⁴Information Ratio measures the reward-to-risk efficiency of the portfolio relative to the benchmark. The higher the number, the higher the reward per unit of risk. This is computed by dividing the excess return of the fund against the benchmark over the fund's volatility.

RELATED PARTY TRANSACTIONS

The Fund has deposits with the Bank Proper, amounting to USD5.39 million, which were approved by the Board of Directors/Trust Investment Committee. Likewise, all related parties transactions are conducted on an arm's length basis.

OUTLOOK AND STRATEGY

In July, the US treasury yield curve bear steepened as inflation jumped, exceeding expectations. Rates rose by 12 basis points (bps) on average, with the belly underperforming, rising by 19 bps on average. The short end jumped by 7 bps, while the long-end rose by 11 bps. The 2s10s narrowed to 43 bps versus last month's 52 bps as the 2-year rate rose by 22 bps to 3.94%, while the 10-year rate rose by 13 bps to 4.37%. Locally, ROPs were relatively flat, falling by an average of just 1 bp for the month, with the 2-year ROP ending at 4.26%, up 2 bps, while the 10-year ROP fetched 4.94%, down 4 bps.

On the labor market front, U.S. nonfarm payrolls rose by 147,000 in June, reflecting a slowdown in private sector hiring. Moreover, the unemployment rate dipped to 4.1% in June, largely because fewer people remained in the labor force. Tariffs and tighter fiscal conditions are weighing on business confidence, limiting the likelihood of near-term rate cuts but leaving room for deeper cuts later. However, latest weekly jobless claims in July dropped to 221,000, below forecasts, indicating ongoing labor market strength, though slower hiring is leading to longer job searches for some.

U.S. headline inflation rose to 2.7% YoY in June, a four-month high, driven partly by energy costs, raising concerns about tariff-related price pressures. Treasury yields climbed as markets dialed back expectations for a September rate cut. Moreover, the latest Federal Open Market Committee minutes revealed the members' cautious stance amid mixed data and inflation uncertainty. While some Fed officials signaled cuts as early as July, others favored holding rates through year-end. While majority projects rate cuts for 2025, views on how soon and how many vary. The Federal Reserve also noted tariff-driven inflation as likely temporary but warns of risks if inflation stays high as the labor market cools. Given this backdrop, investors will closely monitor inflation, employment data, and U.S. trade policy updates. The Fund remains focused on maintaining liquidity while seeking to boost returns through selective investments in time deposits.

INVESTMENT POLICY / PROSPECTIVE INVESTMENTS

The Fund may be invested or reinvested in the following:

- a) Deposits with local banks, including those of the Trustee's own bank;
- b) Deposits with foreign banks or their Philippine branches or any financial institution in any foreign country; and
- c) Such other tradable investment outlets/categories as the Bangko Sentral ng Pilipinas (BSP) may allow.
