### INVESTMENT OBJECTIVE AND STRATEGY

The Chinabank Dollar Cash Fund intends to achieve liquidity and to potentially earn higher than USD time deposits by investing in fixed income securities of mostly time deposits, special savings accounts and government securities with a weighted average portfolio modified duration of not more than one (1) year. The Fund aims to outperform its benchmark which is the Bloomberg US Treasury Bills 3-6 Months Index.

### CLIENT SUITABILITY

A client profiling process shall be performed prior to participating in the Fund to guide the prospective investor if the Fund is suited to his/her investment objectives and risk tolerance. Before deciding to invest, clients are advised to read the Declaration of Trust, a copy of which is available at the Trustee's principal office.

**The Chinabank Dollar Cash Fund is suitable only for investors who:**

- have a conservative risk appetite;
- are seeking a high level of liquidity with returns better than deposits; and,
- have an investment horizon of one (1) year or less.

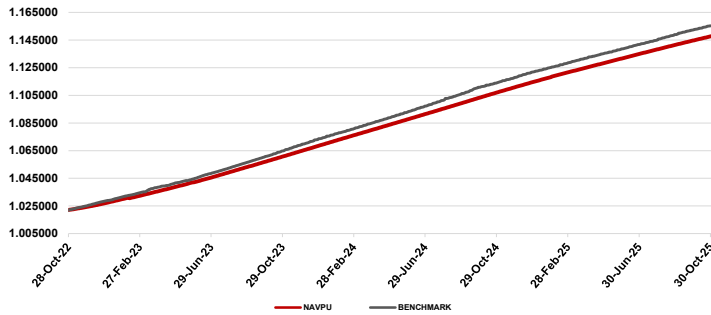

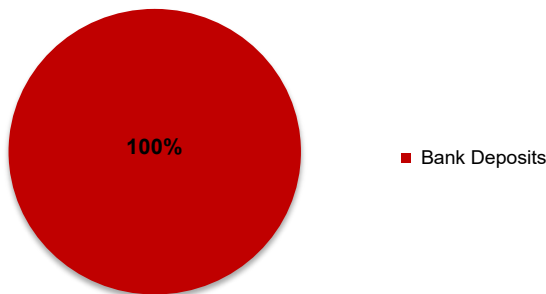

<sup>2</sup>**Volatility** measures the degree to which the Fund fluctuates vis-à-vis its average return over a period of time. This is computed by getting the standard deviation of the yearly returns for the past 12 mos.

<sup>3</sup>**Sharpe Ratio** is used to characterize how well the return of a Fund compensates the investor for the level of risk taken. The higher the number, the better. This is computed by dividing the excess return of the fund against the risk-free rate over the fund's volatility.

<sup>4</sup>**Information Ratio** measures the reward-to-risk efficiency of the portfolio relative to the benchmark. The higher the number, the higher the reward per unit of risk. This is computed by dividing the excess return of the fund against the benchmark over the fund's volatility.

The Fund has deposits with the Bank Proper, amounting to USD5.70 million, which were approved by the Board of Directors/Trust Investment Committee. Likewise, all related parties transactions are conducted on an arm's length basis.

**OUTLOOK AND STRATEGY**

In October, the U.S. Treasury yield curve bull steepened as the US Federal Reserve (Fed) cut its policy rate amid labor market concerns. Rates across the curve fell by 6 basis points (bps) on average, with the short end outperforming, falling by 9 bps. Meanwhile, the belly of the curve declined by 2 bps and the long-end was down 6 bps. The 2-year rate was flat at 3.6% and the 10-year rate fell by 5 bps to 4.11%, slightly narrowing the 2s10s spread to 51 bps versus last month's 56 bps. ROPs tracked treasuries' movement as rates fell by 16 bps on average. The 2-year ROP fell 4 bps to 3.93% while the 10-year ROP fetched 4.61%, down 1 bp versus last month.

U.S. macro data reflected mixed signals as the government shutdown continued, delaying labor indicators and other key releases. Initial jobless claims ticked up to an estimated 235,000 early in October, largely due to temporary layoffs from halted federal contracts, though economists expect claims to retrace once operations normalize. The Fed's Beige Book pointed to growing labor market softness, with firms trimming staff in response to weakening demand and rising AI-driven efficiencies. Meanwhile, consumer spending decelerated among lower-income households, even as high-income consumers sustained broader activity. Inflation moderated further, with September consumer price index rising 0.3% mom and 3.0% yoy, slightly below expectations, while easing rent gains offset higher gasoline prices.

Amid this economic environment, policymakers maintained a cautious easing bias. Fed Chair Powell noted that the economy remains on a firmer footing despite subdued hiring and signaled the balance sheet runoff may conclude soon. The Fed delivered its second consecutive 25-bp cut, bringing the policy rate to 3.75-4.00%, with future moves dependent on incoming data ahead of December. Markets now expect an additional cut in October. Looking ahead, we expect market to take its cue from inflation and employment data as they become available to anticipate the Fed's next moves. The Fund remains strategically positioned across time deposits to balance liquidity and returns.

## INVESTMENT POLICY / PROSPECTIVE INVESTMENTS

The Fund may be invested or reinvested in the following:

- a) Deposits with local banks, including those of the Trustee's own bank;
- b) Deposits with foreign banks or their Philippine branches or any financial institution in any foreign country; and
- c) Such other tradable investment outlets/categories as the Bangko Sentral ng Pilipinas (BSP) may allow.
