INVESTMENT OBJECTIVE AND STRATEGY

The Chinabank Dollar Fixed Income Fund intends to achieve a steady stream of income by investing in a diversified portfolio of high-grade marketable securities comprised mainly of Philippine sovereign bonds as well as US treasury bonds of varying tenors with a weighted average portfolio modified duration of not more than ten (10) years. The Fund aims to outperform its benchmark which is the Bloomberg EM USD Sovereign-Philippine Total Return Index.

CLIENT SUITABILITY

A client profiling process shall be performed prior to participating in the Fund to guide the prospective investor if the Fund is suited to his/her investment objectives and risk tolerance. Before deciding to invest, clients are advised to read the Declaration of Trust, a copy of which is available at the Trustee's principal office.

The Chinabank Dollar Fixed Income Fund is suitable only for investors who:

- have a moderate risk appetite;
- are willing to assume a certain level of risk in consideration for higher returns; and
- have an investment horizon of at least five (5) years.

KEY RISKS AND RISK MANAGEMENT

The client should not invest in this Fund if the client does not understand or is not comfortable with the accompanying risks.

- Interest Rate Risk. This is the possibility for an investor to experience losses due to changes in interest rates. The purchase and sale of a debt instrument may result in profit or loss because the value of a debt instrument changes inversely with prevailing interest rates.

The Fund also employs risk management measures to monitor significant declines in the Fund's NAVPu and alert the Trustee to review current strategies and take corrective action as necessary. Furthermore, the Fund undergoes an annual review to ensure that it is equipped to fund any redemption requirement in a timely manner and at a reasonable cost during times of financial stress.

Additionally, the benchmark's characteristics serve as a reference point for the Fund's duration and credit positioning.

²Volatility measures the degree to which the Fund fluctuates vis-à-vis its average return over a period of time. This is computed by getting the standard deviation of the yearly returns for the past 12 mos.

³Sharpe Ratio is used to characterize how well the return of a Fund compensates the investor for the level of risk taken. The higher the number, the better. This is computed by dividing the excess return of the fund against the risk-free rate over the fund's volatility.

⁴Information Ratio measures the reward-to-risk efficiency of the portfolio relative to the benchmark. The higher the number, the higher the reward per unit of risk. This is computed by dividing the excess return of the fund against the benchmark over the fund's volatility.

RELATED PARTY TRANSACTIONS

The Fund has deposits with the Bank Proper, amounting to USD240.87 thousand, which were approved by the Board of Directors/Trust Investment Committee. Likewise, all related parties transactions are conducted on an arm's length basis.

OUTLOOK AND STRATEGY

The conflict in the Middle East dominated news headlines in June. Israel launched a major attack on Iran's nuclear facilities, which Iran responded to with barrages of ballistic missiles and drones. The intense fighting lasted for days and escalated further when the United States attacked three nuclear sites in Iran. During this period, Brent Oil futures soared from \$63.90 per barrel to \$81.40 per barrel amid concerns about supply disruptions. The equity market's fear gauge, the VIX, also increased from 18.57 to 22.5. Since then, a ceasefire between Israel and Iran has held, causing Brent Oil and the VIX to retreat to \$67.51 per barrel and 16.73, respectively. Outside geopolitics, monetary policy developments also affected market movements. The US Federal Reserve decided to keep policy rates in the 4.25%-4.50% range, as widely expected. The Fed's dot plot revealed that committee members continued to expect at least 2 25-basis-point rate cuts for 2025. However, for 2026 and 2027, the number of expected rate cuts has been reduced to one per year instead of

two. Additionally, the Fed released its latest summary of economic projections, which showed that for 2025, GDP growth is expected to be slower at 1.4%, down from 1.7% previously. The Core Personal Consumption Expenditure, meanwhile, is now expected to reach 3.1%, up from the previously reported 2.8%. Meanwhile, in the local market, the Bangko Sentral ng Pilipinas (BSP) cut its policy rate by 25 basis points to 5.25%. BSP Governor Remolona stated that the central bank has room for at least one more cut this year. The peso weakened against the US dollar during the month, reaching a low of 57.614 before recovering to 56.322.

Government bond yields declined in June, driven by heightened demand for safe-haven assets amid geopolitical risks. In the US, the 2-year Treasury yield fell by 18 basis points to 3.707%, while the 10-year yield declined by 16 basis points to 4.251%. Year to date, this contributes to a continued steepening of the yield curve, with the 2-year and 10-year yields lower by 62 basis points and 39 basis points, respectively. Rate cut expectations added further downward pressure on yields. Markets are also closely watching political developments, as US President Donald Trump has hinted at naming Jerome Powell's successor as the Federal Reserve Chair, citing that interest rates should already be lower. The Philippine USD-denominated bond curve mirrored the move in US Treasuries. The 2-year yield dropped by four basis points to 4.286%, while the 10-year yield fell by 14 basis points to 5.02%. On a year-to-date basis, these maturities have declined by 73 basis points and 39 basis points, respectively.

In the coming month, market participants will be closely monitoring updates on President Trump's proposed tax reform bill, as well as the expiration of the 90-day truce on reciprocal tariffs, set for July 9. Given its potential implications on the deficits and inflation expectations, which long-dated securities are sensitive to, the Fund will manage interest rate risks by maintaining a neutral duration relative to its benchmark. At the same time, the Fund will remain opportunistic in its bond acquisitions to gradually build up portfolio yield.

INVESTMENT POLICY / PROSPECTIVE INVESTMENTS

The Fund may be invested or reinvested in the following:

- a) Securities issued by or guaranteed by the Philippine government or the Bangko Sentral ng Pilipinas (BSP);
- b) Tradable securities issued by the government of a foreign country, any political subdivision of a foreign country or any supranational entity;
- c) Tradable fixed income securities issued by private and public corporations which are listed and traded in an organized exchange/market such as bonds, notes and preferred shares which are classified as debt securities under appropriate accounting standards;
- d) Deposits and tradable money market instruments issued by local banks, including those of the Trustee's own bank, and foreign banks or their Philippine branches or any financial institution in any foreign country;
- e) Financial derivatives instruments solely for the purpose of hedging risk exposures of the existing investments of the Fund, provided that these are accounted for in accordance with existing BSP hedging guidelines as well as the Trustee's risk management and hedging policies duly approved by the Trust Investment Committee and disclosed to participants; and
- f) Such other tradable investment outlets/categories as the BSP may allow.
