INVESTMENT OBJECTIVE AND STRATEGY

The Chinabank Fixed Income Fund intends to achieve a steady stream of income by investing in a diversified portfolio of high-grade marketable fixed income securities such as government securities, tradable corporate bonds and notes of varying tenors as well as bank deposits, money market placements and BSP securities with a weighted average portfolio modified duration of not more than ten (10) years. The Fund aims to outperform its benchmark which is the Bloomberg Philippine Sovereign Bond Index 5+ Year (BPHIL5 Index).

CLIENT SUITABILITY

A client profiling process shall be performed prior to participating in the Fund to guide the prospective investor if the Fund is suited to his/her investment objectives and risk tolerance. Before deciding to invest, clients are advised to read the Declaration of Trust, a copy of which is available at the Trustee's principal office.

The Chinabank Fixed Income Fund is suitable only for investors who:

- have a moderate risk appetite;
- are looking for higher yields;
- are willing to take the attendant risks that come with portfolios that may have investments with longer tenors; and,
- have an investment horizon of at least five (5) years.

KEY RISKS AND RISK MANAGEMENT

- Interest Rate Risk. This is the possibility for an investor to experience losses due to changes in interest rates. The purchase and sale of a debt instrument may result in profit or loss because the value of a debt instrument changes inversely with prevailing interest rates.

The Fund also employs risk management measures to monitor significant declines in the Fund's NAVPu and alert the Trustee to review current strategies and take corrective action as necessary. The Fund also undergoes an annual review to ensure that it is equipped to fund any redemption requirement in a timely manner and at a reasonable cost during times of financial strates.



The BPHIL5 Index is a systematically designed, rules-based, market value-weighted index that measures the performance of long-term, fixed-rate local currency securities that are publicly issued by the Philippines. It includes a diversified range of fixed income securities with different coupon rates, maturities of 5 years or more, minimum par amounts of Php3.0Bn, and are traded in the Philippine market. This Index is adjusted for tax by the Trustee, but does not reflect deductions for fees and expenses. Additional information on the benchmark and/or its administrator can be found on Bloomberg, and be made available to investors upon request.

The benchmark provides a standard for evaluating the Fund's performance by helping investors/participants understand how the Fund is performing relative to the market or asset class the Fund represents. The benchmark reflects the performance of pesodenominated fixed income securities with maturities of 5 years or more. Additionally, its characteristics serve as reference point for the Fund's duration and credit positioning.

²**Volatility** measures the degree to which the Fund fluctuates vis-à-vis its average return over a period of time. This is computed by getting the standard deviation of the yearly returns for the past 12 mos.

³Sharpe Ratio is used to characterize how well the return of a Fund compensates the investor for the level of risk taken. The higher the number, the better. This is computed by dividing the excess return of the fund against the risk-free rate over the fund's volatility.

⁴Information Ratio measures the reward-to-risk efficiency of the portfolio relative to the benchmark. The higher the number, the higher the reward per unit of risk. This is computed by dividing the excess return of the fund against the benchmark over the fund's volatility.

RELATED PARTY TRANSACTIONS

The Fund has deposits with the Bank Proper, amounting to Php485.85 thousand, which were approved by the Board of Directors/Trust Investment Committee. Likewise, all related parties transactions are conducted on an arm's length basis.

OUTLOOK AND STRATEGY

The local yield curve continued to steepen in October. Month-over-month, the 2-year yield dropped by 18bps to close at 5.3887%, while the 10-year eased 11bps to 5.9313%. In contrast, yields on the long end remained elevated, with the 20-year yield rising 4bps to 6.422%. These movements contributed to the year-to-date steepening trend, with the 2-year and 10-year yields declining by 66bps and 23bps, respectively, while the 20-year yield increased by 32bps. During the month, the peso continued to depreciate against the US dollar, reaching a low of 59.135 on a closing basis before ending the month at 58.21. The currency's weakness was partly due to the narrowing interest rate differential with the United States following the Bangko Sentral ng Pilipinas' (BSP) surprise policy rate cut to 4.75%. The decision came as inflation remained comfortably below the BSP's 2-4% target, rising only slightly to 1.7% in September from 1.5% in August. The BSP stated that the move aimed to support domestic demand, given the soft business sentiment and ongoing concerns related to governance on public infrastructure spending.

In the auction space, the Bureau of the Treasury (BTr) held two dual-tranche bond auctions. The first occurred in the second week of October, with a Php15 billion offering of the 3-year FXTN 07-64 fully awarded at an average yield of 5.698%, with a bid-to-cover ratio of 2.3x. The Php20 billion issuance of the 10-year FXTN 10-73 also received strong participation, with a 2.17x bid-to-cover ratio and an average yield of 6.043%. The second auction took place in the fourth week of the month. The 7-year FXTN 10-69 was fully awarded at an average yield of 5.798%, with the Php20 billion offer attracting demand of 2.8x. Meanwhile, the 25-year FXTN 25-12 was also fully awarded on a Php15 billion offer, although demand was moderate, as reflected in a bid-to-cover ratio of 1.2x. In other news, the BTr reported that the national government's outstanding debt stood at Php17.46 trillion as of the end of September 2025, declining by Php13.09 billion as repayments exceeded new issuances. Domestic and external borrowing accounted for 68.6% and 31.4%, respectively, in line with the government's strategy to reduce foreign currency risk.

Looking ahead, the BTr is scheduled to hold another set of dual-tranche auctions in November, with 5- and 10-year bonds in the first week, and 7- and 20-year bonds in the third week. Meanwhile, the BSP will hold its final monetary board meeting in December, where another policy rate cut is expected. Against this backdrop, the Fund remains selective in bond acquisitions, seeking to enhance portfolio yield while carefully managing duration risk.

INVESTMENT POLICY / PROSPECTIVE INVESTMENTS

The Fund may be invested or reinvested in the following:

- a) Securities issued by or guaranteed by the Philippine government or the Bangko Sentral ng Pilipinas (BSP);
- b) Tradable fixed income securities issued by private and public corporations which are listed and traded in an organized exchange/market such as bonds, notes and preferred shares which are classified as debt securities under appropriate accounting standards;
- c) Deposits and tradable money market instruments issued by local banks, including those of the Trustee's own bank, and foreign banks or their Philippine branches or any financial institution in any foreign country;
- d) Financial derivatives instruments solely for the purpose of hedging risk exposures of the existing investments of the Fund, provided that these are accounted for in accordance with existing BSP hedging guidelines as well as the Trustee's risk management and hedging policies duly approved by the Trust Investment Committee and disclosed to participants; and
- e) Such other tradable investment outlets/categories as the BSP may allow.
