INVESTMENT OBJECTIVE AND STRATEGY

The Chinabank Fixed Income Fund intends to achieve a steady stream of income by investing in a diversified portfolio of high-grade marketable fixed income securities such as government securities, tradable corporate bonds and notes of varying tenors as well as bank deposits, money market placements and BSP securities with a weighted average portfolio modified duration of not more than ten (10) years. The Fund aims to outperform its benchmark which is the Bloomberg Philippine Sovereign Bond Index 5+ Year (BPHIL5 Index).

CLIENT SUITABILITY

A client profiling process shall be performed prior to participating in the Fund to guide the prospective investor if the Fund is suited to his/her investment objectives and risk tolerance. Before deciding to invest, clients are advised to read the Declaration of Trust, a copy of which is available at the Trustee's principal office.

The Chinabank Fixed Income Fund is suitable only for investors who:

- have a moderate risk appetite;
- are looking for higher yields;
- are willing to take the attendant risks that come with portfolios that may have investments with longer tenors; and,
- have an investment horizon of at least five (5) years.

KEY RISKS AND RISK MANAGEMENT

The client should not invest in this Fund if the client does not understand or is not comfortable with the accompanying risks.

- **Interest Rate Risk.** This is the possibility for an investor to experience losses due to changes in interest rates. The purchase and sale of a debt instrument may result in profit or loss because the value of a debt instrument changes inversely with prevailing interest rates.
- **Market/Price Risk.** This is the possibility for an investor to experience losses due to changes in the market price of securities. It is the exposure to the uncertain market value of a portfolio due to price fluctuations.
- **Liquidity Risk.** This is the possibility for an investor to experience losses due to the inability to sell or convert assets into cash immediately or in instances where conversion to cash is possible but at a loss. These may be caused by different reasons such as trading in securities with small or few outstanding issues, absence of buyers, limited buy/sell activity or underdeveloped capital market.

It also includes risk on a counterparty (a party the Trustee trades with) defaulting on a contract to deliver its obligation either in cash or securities.
- **Reinvestment Risk.** This is the possibility for an investor to have lower returns or earnings when maturing funds or the interest earnings of funds are reinvested.

The Trustee only transacts with reputable counterparties and invests in debt securities issued by prime corporate borrowers which have undergone a rigorous accreditation and evaluation process. Regulatory exposure limits as well as the Fund's average duration are monitored regularly to ensure that exposures are managed. The Fund also employs risk management measures to monitor significant declines in the Fund's NAVPU and alert the Trustee to review current strategies and take corrective action as necessary. The Fund also undergoes an annual review to ensure that it is equipped to fund any redemption requirement in a timely manner and at a reasonable cost during times of financial stress.

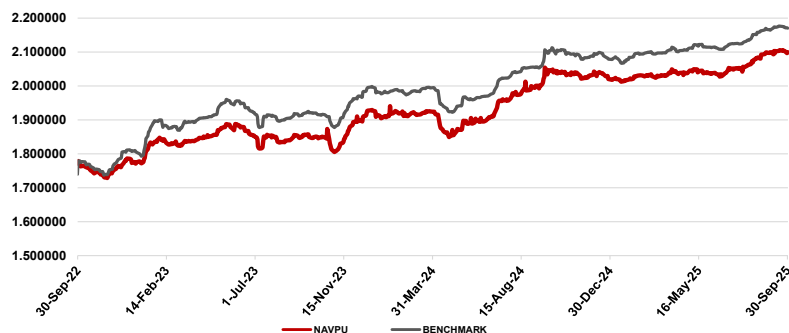

NAVPU GRAPH



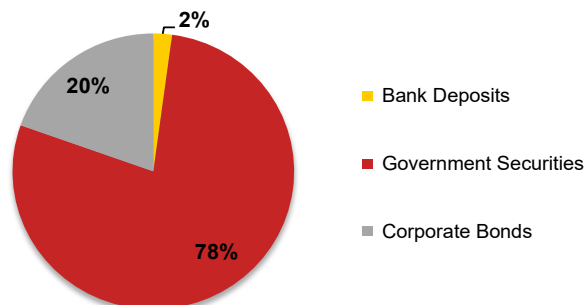

The BPHIL5 Index is a systematically designed, rules-based, market value-weighted index that measures the performance of long-term, fixed-rate local currency securities that are publicly issued by the Philippines. It includes a diversified range of fixed income securities with different coupon rates, maturities of 5 years or more, minimum par amounts of Php3.0Bn, and are traded in the Philippine market. This Index is adjusted for tax by the Trustee, but does not reflect deductions for fees and expenses. Additional information on the benchmark and/or its administrator can be found on Bloomberg, and be made available to investors upon request.

The benchmark provides a standard for evaluating the Fund's performance by helping investors/participants understand how the Fund is performing relative to the market or asset class the Fund represents. The benchmark reflects the performance of peso-denominated fixed income securities with maturities of 5 years or more. Additionally, its characteristics serve as reference point for the Fund's duration and credit positioning.

²**Volatility** measures the degree to which the Fund fluctuates vis-à-vis its average return over a period of time. This is computed by getting the standard deviation of the yearly returns for the past 12 mos.

³**Sharpe Ratio** is used to characterize how well the return of a Fund compensates the investor for the level of risk taken. The higher the number, the better. This is computed by dividing the excess return of the fund against the risk-free rate over the fund's volatility.

⁴**Information Ratio** measures the reward-to-risk efficiency of the portfolio relative to the benchmark. The higher the number, the higher the reward per unit of risk. This is computed by dividing the excess return of the fund against the benchmark over the fund's volatility.

RELATED PARTY TRANSACTIONS

The Fund has deposits with the Bank Proper, amounting to Php5.30 million, which were approved by the Board of Directors/Trust Investment Committee. Likewise, all related parties transactions are conducted on an arm's length basis.

OUTLOOK AND STRATEGY

The local yield curve steepened in September as movements diverged between short- and long-term securities. Yields on the one-year and two-year notes fell by 11 bps and 6 bps to 5.43% and 5.57%, respectively, as the market expected that the Bangko Sentral ng Pilipinas still has room to deliver another rate cut from the current 5% before year-end. This expectation followed the United States Federal Reserve's 25 bp cut to a range of 4.00% to 4.25%. In contrast, medium- to long-term bonds saw modest upward pressure. The 10-year benchmark increased by 1 bp to 6.04%, while the 25-year rose by 5 bps to 6.38%. Meanwhile, the Philippine peso weakened by 2.07% to 58.388 against the US dollar, as market sentiment was weighed down by the corruption scandal involving flood control projects. The ongoing investigation could delay government spending as disbursements face tighter scrutiny, posing risks to growth targets.

In the auction space, the Bureau of the Treasury conducted a full schedule of issuances across the curve. The seven-year FXTN 10-69 opened the month with a Php30 billion offering, fully awarded at an average rate of 5.939% and a bid-to-cover ratio of 2.22x. This was

followed by a Php30 billion auction of the five-year FXTN 07-70, which drew strong demand with a 2.66x bid-to-cover ratio at 5.772%. The 10-year FXTN also received solid participation, with a Php25 billion issuance fully awarded at 5.907% and a 3.09x bid-to-cover ratio. The month concluded with a dual-tranche offering of Php10 billion in three-year FXTN 07-64 and Php25 billion in 20-year bonds. The shorter tenor was met with robust demand, posting a 3.79x bid-to-cover ratio at an average yield of 5.605%, while demand for the 20-year bond was more muted. The Treasury partially awarded Php16.85 billion at an average yield of 6.421% and a bid-to-cover ratio of 1.0x.

For the fourth quarter, the borrowing program was set at Php175 billion, significantly lower than the over Php365 billion offered in previous quarters. The smaller dual-tranche auctions, totaling Php35 billion twice per month, are expected to provide support to bond prices. On a separate note, the Philippines was placed on JPMorgan's positive watchlist for potential re-entry into its Government Bond Index Emerging Markets, inclusion to which is expected to help attract foreign investment, improve market liquidity, and reduce borrowing costs. Against this backdrop, the Fund remains selective in bond acquisitions, seeking to enhance portfolio yield while carefully managing duration risk.

INVESTMENT POLICY / PROSPECTIVE INVESTMENTS

The Fund may be invested or reinvested in the following:

- a) Securities issued by or guaranteed by the Philippine government or the Bangko Sentral ng Pilipinas (BSP);
- b) Tradable fixed income securities issued by private and public corporations which are listed and traded in an organized exchange/market such as bonds, notes and preferred shares which are classified as debt securities under appropriate accounting standards;
- c) Deposits and tradable money market instruments issued by local banks, including those of the Trustee's own bank, and foreign banks or their Philippine branches or any financial institution in any foreign country;
- d) Financial derivatives instruments solely for the purpose of hedging risk exposures of the existing investments of the Fund, provided that these are accounted for in accordance with existing BSP hedging guidelines as well as the Trustee's risk management and hedging policies duly approved by the Trust Investment Committee and disclosed to participants; and
- e) Such other tradable investment outlets/categories as the BSP may allow.
