INVESTMENT OBJECTIVE AND STRATEGY

The Chinabank Income-Paying Dollar Bond Feeder Fund intends to achieve regular income with a secondary focus on long term capital growth by investing in a Target Fund that seeks to track the performance of a broad, market-weighted, investment-grade U.S. bond market. The Fund aims to provide a return that tracks the performance of the Bloomberg U.S. Aggregate Float Adjusted Index, which is the benchmark of the Target Fund.

CLIENT SHITABILITY

A client profiling process shall be performed prior to participating in the Fund to guide the prospective investor if the Fund is suited to his/her investment objectives and risk tolerance. Before deciding to invest, clients are advised to read the Declaration of Trust, a copy of which is available at the Trustee's principal office and website.

The Chinabank Income-Paying Dollar Bond Feeder Fund is suitable only for investors who:

- have a moderate risk appetite;
- are willing to assume a certain level of risk in consideration for higher returns; and
- have an investment horizon of at least five (5) years.

KEY RISKS AND RISK MANAGEMENT

The client should not invest in this Fund if the client does not understand or is not comfortable with the accompanying risks.



The Fund also employs risk management measures to monitor significant declines in the Fund's NAVPu and alert the Trustee to review current strategies and take corrective action as necessary. Furthermore, the Fund undergoes an annual review to ensure that it is equipped to fund any redemption requirement in a timely manner and at a reasonable cost during times of financial stress.

The Bloomberg U.S. Aggregate Float Index is a Total Return Index which measures the performance of a wide spectrum of public, investment-grade, taxable, fixed income securities in the U.S. – including government, corporate and international dollar-denominated bonds, as well as mortgage-backed and asset-backed securities – all with maturities of more than one (1) year. Federal Reserve holdings acquired through primary and secondary markets are deducted from the outstanding amounts of securities in the index. This Index is not adjusted for tax by the Trustee and does not reflect deductions for fees and expenses. The benchmark provides a standard for evaluating the Fund's performance by helping investors/participants understand how the Fund is performing relative to the performance of the broad, investment-grade US bond market, to which the Target Fund invests. As part of the Fund's index sampling strategy, at least 80% of its assets will be invested in bonds held in the benchmark. Additionally, the benchmark's characteristics serve as reference point for the Fund's duration, credit quality, and yield to maturity, among others. The performance figures for the Benchmark reflect total return, whereas the figures for the Fund and the Target Fund do not include the income paid out on distribution and are based on price changes only.



⁴**Sharpe Ratio** is used to characterize how well the return of a Fund compensates the investor for the level of risk taken. The higher the number, the better. This is computed by dividing the excess return of the fund against the risk-free rate over the fund's volatility.

⁵Information Ratio measures the reward-to-risk efficiency of the portfolio relative to the benchmark. The higher the number, the higher the reward per unit of risk. This is computed by dividing the excess return of the fund against the benchmark over the fund's volatility.

RELATED PARTY TRANSACTIONS

The Fund has deposits with the Bank Proper, amounting to USD4.42 thousand, which were approved by the Board of Directors/Trust Investment Committee. Likewise, all related parties transactions are conducted on an arm's length basis.

OUTLOOK AND STRATEGY

U.S. President Donald Trump's trade war escalated in March. The month began with Trump increasing the import tariffs from China from 10% to 20%. In response, China imposed a 10-15% tariff on selected U.S. products. At the same time, the U.S.'s 25% tariff on imports from Canada and Mexico took effect, although some exemptions were made. Later in the month, additional measures were announced, including a 25% tariff on imports from countries purchasing Venezuelan oil and a 25% tariff on all imported automobiles.

Risk assets reacted negatively to these developments, with the MSCI All-Country World Equity Index and the S&P 500 Index falling by 4.14% and 4.18%, respectively. Unsurprisingly, demand for safe-haven assets was strong. The yield of the 2-year U.S. Treasury declined by 9.5 bps from a month ago and ended at 3.89%. Meanwhile, the 10-year yield increased by 1.8 bps to 4.23%, resulting in a steeper curve. Shifting to monetary policy, as widely expected, the Federal Reserve kept the funds rate unchanged at the 4.25%-4.50% level in their March meeting. For 2025, the Fed's latest dot plot revealed that the median projection of two interest rate cuts was also unchanged. Looking at the CME FedWatch tool, the futures market is pricing in a 72.8% probability of seeing one rate cut by the end of the year and a 44.6% probability of seeing two. Recently, there have been increasing discussions about the risk of potential stagflation in the world's largest economy. The U.S. Federal Reserve appears to validate these expectations, as its summary of economic projections for 2025 shows a downgrade in its GDP estimate from 2.10% to 1.70%. At the same time, the central bank raised its inflation forecast, with core CPI now expected to reach 2.80%, up from the previous 2.50%. The Fed also revised its unemployment rate projections from 4.20% to 4.40%. Notably, during the same 2-day meeting, the Fed announced its decision to slow the pace of its balance sheet reduction, trimming its U.S. Treasury runoff from US\$25 billion to US\$5 billion. Some market participants interpreted this as a form of policy easing in itself.

Looking ahead, the current risk-off tone will likely remain as Trump looks set to impose sweeping changes on trade policies. On April 2, Trump is scheduled to unveil his reciprocal tariff updates, an event which he refers to as "Liberation Day." All these factors, along with the Fed's monetary policy response, may mean that bond investments will be well supported.

INVESTMENT POLICY / PROSPECTIVE INVESTMENTS

The Fund shall invest at least ninety percent (90%) of its assets in the Target Fund. The Fund may also invest in deposit products such as time deposits/other bank deposit products.

The Fund may have cash levels in excess of 10% if (i) there is a large subscription and the Trustee is in the process of investing the cash contribution into the Target Fund; (ii) there is a large redemption wherein the Trustee has already received the proceeds from its divestment from the Target Fund but is awaiting the end of the redemption settlement period; or (iii) the Trustee is in the process of switching from one Target Fund to another.
