# **INVESTMENT OBJECTIVE AND STRATEGY**

The Chinabank Income-Paying Dollar Bond Feeder Fund intends to achieve regular income with a secondary focus on long term capital growth by investing in a Target Fund that seeks to track the performance of a broad, market-weighted, investment-grade U.S. bond market. The Fund aims to provide a return that tracks the performance of the Bloomberg U.S. Aggregate Float Adjusted Index, which is the benchmark of the Target Fund.

#### **CLIENT SUITABILITY**

A client profiling process shall be performed prior to participating in the Fund to guide the prospective investor if the Fund is suited to his/her investment objectives and risk tolerance. Before deciding to invest, clients are advised to read the Declaration of Trust, a copy of which is available at the Trustee's principal office and website.

# The Chinabank Income-Paying Dollar Bond Feeder Fund is suitable only for investors who:

- Have a moderate risk appetite;
- Are willing to assume a certain level of risk in consideration for higher returns; and,
- Have an investment horizon of at least five (5) years.

## KEY RISKS AND RISK MANAGEMENT


As ETF Shares are traded on an exchange, they are also subject to additional risks:

- The Target Fund's ETF Shares are listed for trading on Nasdaq and are bought and sold on the secondary market at market prices. Although it is expected that the market price of an ETF Share typically will approximate its NAV, there may be times when the market price and the NAV differ significantly. Thus, the Fund may pay more or less than the NAV when buying ETF Shares on the secondary market, and the Fund may receive more or less than the NAV when selling the shares.
- Although the Target Fund's ETF Shares are listed for trading on Nasdaq, it is possible that an active trading market may not be maintained.
- Trading of the Target Fund's ETF Shares may be halted by the activation of individual or marketwide trading halts (which halt
  trading for a specific period of time when the price of a particular security or overall market prices decline by a specified
  percentage). Trading of the Target Fund's ETF Shares may also be halted if (1) the shares are delisted from Nasdaq without
  first being listed on another exchange or (2) Nasdaq officials determine that such action is appropriate in the interest of a fair
  and orderly market or for the protection of investors.

The Trustee only transacts with reputable counterparties and invests in Target Funds and securities which have undergone a rigorous accreditation and evaluation process. Regulatory exposure limits are monitored regularly to ensure that exposures are managed. The Fund also employs risk management measures to monitor significant declines in the Fund's NAVPu and alert the Trustee to review current strategies and take corrective action as necessary. Furthermore, the Fund undergoes an annual review to ensure that it is equipped to fund any redemption requirement in a timely manner and at a reasonable cost during times of financial stress.

The Bloomberg U.S. Aggregate Float Index is a Total Return Index which measures the performance of a wide spectrum of public, investment-grade, taxable, fixed income securities in the U.S. – including government, corporate and international dollar-denominated bonds, as well as mortgage-backed and asset-backed securities – all with maturities of more than one (1) year. Federal Reserve holdings acquired through primary and secondary markets are deducted from the outstanding amounts of securities in the index. This Index is not adjusted for tax by the Trustee and does not reflect deductions for fees and expenses. The benchmark provides a standard for evaluating the Fund's performance by helping investors/participants understand how the Fund is performing relative to the performance of the broad, investment-grade US bond market, to which the Target Fund invests. As part of the Fund's index sampling strategy, at least 80% of its assets will be invested in bonds held in the benchmark. Additionally, the benchmark's characteristics serve as reference point for the Fund's duration, credit quality, and yield to maturity, among others. The performance figures for the Benchmark reflect total return, whereas the figures for the Fund and the Target Fund do not include the income paid out on distribution and are based on price changes only.



<sup>3</sup>Sharpe Ratio is used to characterize how well the return of a Fund compensates the investor for the level of risk taken. The higher the number, the better. This is computed by dividing the excess return of the fund against the risk-free rate over the fund's volatility.

<sup>4</sup>Information Ratio measures the reward-torisk efficiency of the portfolio relative to the benchmark. The higher the number, the higher the reward per unit of risk. This is computed by dividing the excess return of the fund against the benchmark over the fund's volatility.

## **RELATED PARTY TRANSACTIONS**

The Fund has deposits with the Bank Proper, amounting to USD44.88 thousand, which were approved by the Board of Directors/Trust Investment Committee. Likewise, all related parties transactions are conducted on an arm's length basis.

#### **OUTLOOK AND STRATEGY**

In November, the US yield curve bull flattened on the back of increased probability of a Federal Reserve (Fed) policy rate cut in December, and as markets digested the implications of the new Trump presidency. Treasury yields fell by 7 basis points (bps) on average, with the long-end outperforming the rest of the curve. Rates in the long-end fell by 11 bps on average, with the 10-year rate down 10 bps to fetch 4.18%. Meanwhile, rates in the belly were down 7 bps and short-end rates fell by 2 bps versus previous month. The 2-year rate was down 3 bps to 4.13%, bringing the benchmark 2-year versus 10-year spread to 0.05 from 0.12 in October.

Inflation ticked up slightly in October, with the PCE price index rising 0.2% month-over-month, pushing the annual rate to 2.3% from 2.1% in September. Core inflation also increased, driven by higher services costs. Although still above the Fed's 2% target, inflation has significantly cooled from its 2022 peak, reflecting earlier rate hikes. In response, the Fed approved a second consecutive rate cut, lowering the benchmark rate by 0.25% to 4.50%-4.75%. The move, following September's larger 0.50% cut, aligns with market expectations, which predict another quarter-point reduction in December. The unanimous decision reflects the Fed's growing focus on supporting employment alongside controlling inflation.

Macroeconomic data from October 2024 painted a mixed picture. US new home sales fell sharply to an annualized 610,000 units, down 17.3% from September and 9.4% year-over-year, as high mortgage rates and record median home prices of \$437,300 weighed on demand. Inventory rose to 481,000 units, a two-year high, equivalent to a 9.5-month supply. Meanwhile, durable goods orders increased by 0.2% to \$286.6 billion, recovering from a 0.4% decline in September but below the 0.5% forecast. Gains were led by transportation equipment (+0.5%), with additional growth in electrical equipment, machinery, and capital goods. However, orders fell for computers and motor vehicles. Excluding transportation, orders rose 0.1%, while non-defense capital goods excluding aircraft, a key business investment indicator, dropped 0.2%.

On the other hand, US initial jobless claims remained steady at 213,000 for the week ending November 23, 2024, below the 216,000 forecast, signaling a resilient labor market despite recent Fed tightening. The four-week average fell to 217,000, though non-seasonally adjusted claims rose by 29,101, driven by increases in California, Illinois, and Pennsylvania. Continuing claims hit 1.9 million, the highest since November 2021. Meanwhile, the services sector accelerated in October, with the ISM index rising to 56 from 54.9 in September, fueled by a recovery in hiring, suggesting that the recent slowdown in job growth was only temporary. This unexpected strength suggested the economy maintained solid momentum heading into the fourth quarter, even as Americans prepared to vote in the presidential election.

In the coming month, we expect the market to take its cue from key macroeconomic data such as inflation and jobs report and from developing news on key policy measures by the new Trump presidency. The Fed's FOMC will also hold its last meeting in December, where the market widely expects a 25-bp rate cut.

## **INVESTMENT POLICY / STRATEGY**

The Fund shall invest at least ninety percent (90%) of its assets in the Target Fund. The Fund may also invest in deposit products such as time deposits/other bank deposit products.

The Fund may have cash levels in excess of 10% if (i) there is a large subscription and the Trustee is in the process of investing the cash contribution into the Target Fund; (ii) there is a large redemption wherein the Trustee has already received the proceeds from its divestment from the Target Fund but is awaiting the end of the redemption settlement period; or (iii) the Trustee is in the process of switching from one Target Fund to another.
