### INVESTMENT OBJECTIVE AND STRATEGY

The Chinabank Income-Paying Dollar Bond Feeder Fund intends to achieve regular income with a secondary focus on long term capital growth by investing in a Target Fund that seeks to track the performance of a broad, market-weighted, investment-grade U.S. bond market. The Fund aims to provide a return that tracks the performance of the Bloomberg U.S. Aggregate Float Adjusted Index, which is the benchmark of the Target Fund.

### CLIENT SUITABILITY

*A client profiling process shall be performed prior to participating in the Fund to guide the prospective investor if the Fund is suited to his/her investment objectives and risk tolerance. Before deciding to invest, clients are advised to read the Declaration of Trust, a copy of which is available at the Trustee's principal office and website.*

**The Chinabank Income-Paying Dollar Bond Feeder Fund is suitable only for investors who:**

- have a moderate risk appetite;
- are willing to assume a certain level of risk in consideration for higher returns; and
- have an investment horizon of at least five (5) years.

### KEY RISKS AND RISK MANAGEMENT


- The Target Fund's ETF Shares are listed for trading on Nasdaq and are bought and sold on the secondary market at market prices. Although it is expected that the market price of an ETF Share typically will approximate its NAV, there may be times when the market price and the NAV differ significantly. Thus, the Fund may pay more or less than the NAV when buying ETF Shares on the secondary market, and the Fund may receive more or less than the NAV when selling the shares.
- Although the Target Fund's ETF Shares are listed for trading on Nasdaq, it is possible that an active trading market may not be maintained.
- Trading of the Target Fund's ETF Shares may be halted by the activation of individual or marketwide trading halts (which halt trading for a specific period of time when the price of a particular security or overall market prices decline by a specified percentage). Trading of the Target Fund's ETF Shares may also be halted if (1) the shares are delisted from Nasdaq without first being listed on another exchange or (2) Nasdaq officials determine that such action is appropriate in the interest of a fair and orderly market or for the protection of investors.

The Trustee only transacts with reputable counterparties and invests in Target Funds and securities which have undergone a rigorous accreditation and evaluation process. Regulatory exposure limits are monitored regularly to ensure that exposures are managed. The Fund also employs risk management measures to monitor significant declines in the Fund's NAVPU and alert the Trustee to review current strategies and take corrective action as necessary. Furthermore, the Fund undergoes an annual review to ensure that it is equipped to fund any redemption requirement in a timely manner and at a reasonable cost during times of financial stress.

### NAVPU GRAPH





The Bloomberg U.S. Aggregate Float Index is a Total Return Index which measures the performance of a wide spectrum of public, investment-grade, taxable, fixed income securities in the U.S. – including government, corporate and international dollar-denominated bonds, as well as mortgage-backed and asset-backed securities – all with maturities of more than one (1) year. Federal Reserve holdings acquired through primary and secondary markets are deducted from the outstanding amounts of securities in the index. This Index is not adjusted for tax by the Trustee and does not reflect deductions for fees and expenses. The benchmark provides a standard for evaluating the Fund's performance by helping investors/participants understand how the Fund is performing relative to the performance of the broad, investment-grade US bond market, to which the Target Fund invests. As part of the Fund's index sampling strategy, at least 80% of its assets will be invested in bonds held in the benchmark. Additionally, the benchmark's characteristics serve as reference point for the Fund's duration, credit quality, and yield to maturity, among others. The performance figures for the Benchmark reflect total return, whereas the figures for the Fund and the Target Fund do not include the income paid out on distribution and are based on price changes only.

<sup>3</sup>**Volatility** measures the degree to which the Fund fluctuates vis-à-vis its average return over a period of time. This is computed by getting the standard deviation of the yearly returns for the past 12 mos.

<sup>4</sup>**Sharpe Ratio** is used to characterize how well the return of a Fund compensates the investor for the level of risk taken. The higher the number, the better. This is computed by dividing the excess return of the fund against the risk-free rate over the fund's volatility.

<sup>5</sup>**Information Ratio** measures the reward-to-risk efficiency of the portfolio relative to the benchmark. The higher the number, the higher the reward per unit of risk. This is computed by dividing the excess return of the fund against the benchmark over the fund's volatility.

## OTHER DISCLOSURES

### RELATED PARTY TRANSACTIONS

The Fund has deposits with the Bank Proper, amounting to USD9.13 thousand, which were approved by the Board of Directors/Trust Investment Committee. Likewise, all related parties transactions are conducted on an arm's length basis.

### OUTLOOK AND STRATEGY

The US Treasury yield curve flattened in September, with the 2-year yield decreasing by 1 bp to 3.68%, while the 10-year dropped by 7 bps to 4.17%.

During the month, the US Federal Reserve lowered policy rates by 25 bps to 4.00% to 4.25%, marking its first move this year following the 50 bp cut in December 2024. Meanwhile, the updated dot plot revealed differing views among the 19 Fed members, with one opposing the cut, six seeing September's move as the last for the year, two expecting one more 25 bp reduction, nine anticipating another 50 bps, and one projecting up to 125 bps of additional easing. The dots also indicated one rate cut each for 2026 and 2027, consistent with the path toward the 3.0% long-run neutral rate. In his post-meeting remarks, Chair Jerome Powell described the decision as a risk management move, citing increasing downside risks to the labor market. Earlier in the month, the Bureau of Labor Statistics (BLS) reported that 22,000 jobs were added in August, well below the 75,000 estimate, following an upwardly revised 79,000 in July and a 13,000-job loss in June after revisions. The BLS's preliminary benchmark revision also showed a negative 911,000 adjustment to payrolls for the year ending March 2025, indicating softer employment conditions. Meanwhile, inflation continues to remain above the Fed's 2.0% target, with headline CPI increasing 2.9% in August from 2.7% in July, as tariffs imposed by the Trump administration exerted upward pressure on prices. The core CPI remained steady at 3.1%. On a more positive note, US GDP growth for the second quarter of 2025 was revised upward to 3.8% from 3.3%, supported by stronger consumer spending of 2.5% compared with the previous estimate of 1.6%.

Looking ahead, markets will focus on upcoming labor and inflation data to determine whether the Fed will follow through with another rate cut in its October meeting. The Fund will continue to track the broad investment-grade US bond market, which remains sensitive to these developments.

## INVESTMENT POLICY / PROSPECTIVE INVESTMENTS

The Fund shall invest at least ninety percent (90%) of its assets in the Target Fund. The Fund may also invest in deposit products such as time deposits/other bank deposit products.

The Fund may have cash levels in excess of 10% if (i) there is a large subscription and the Trustee is in the process of investing the cash contribution into the Target Fund; (ii) there is a large redemption wherein the Trustee has already received the proceeds from its divestment from the Target Fund but is awaiting the end of the redemption settlement period; or (iii) the Trustee is in the process of switching from one Target Fund to another.
