INVESTMENT OBJECTIVE AND STRATEGY

The Chinabank Intermediate Fixed Income Fund intends to achieve income in the intermediate-term by investing in a diversified portfolio of high-grade marketable fixed income securities comprised of deposits issued by banks and other financial institutions including, the BSP securities, tradable money market instruments, government securities, corporate bonds and notes with a weighted average portfolio modified duration of not more than three (3) years, and preferred shares which are classified as debt securities. The Fund aims to outperform its benchmark which is the Bloomberg Philippine Sovereign Bond Index 1 to 3 Year (BPHIL13 Index).

CLIENT SUITABILITY

A client profiling process shall be performed prior to participating in the Fund to guide the prospective investor if the Fund is suited to his/her investment objectives and risk tolerance. Before deciding to invest, clients are advised to read the Declaration of Trust, a copy of which is available at the Trustee's principal office.

The Chinabank Intermediate Fixed Income Fund is suitable only for investors who:

- have a moderate risk appetite;
- are willing to assume a certain level of risk in consideration for higher returns; and
- have an investment horizon of at least three (3) years.

KEY RISKS AND RISK MANAGEMENT

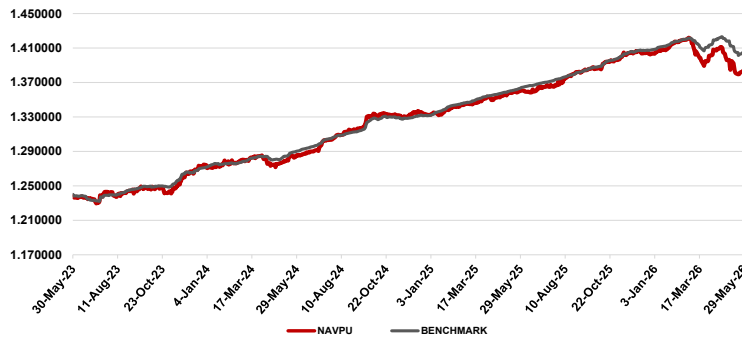

- **Interest Rate Risk.** This is the possibility for an investor to experience losses due to changes in interest rates. The purchase and sale of a debt instrument may result in profit or loss because the value of a debt instrument changes inversely with prevailing interest rates.
- **Market/Price Risk.** This is the possibility for an investor to experience losses due to changes in the market price of securities. It is the exposure to the uncertain market value of a portfolio due to price fluctuations.

Regulatory exposure limits as well as the Fund's average duration are monitored regularly to ensure that exposures are managed. The Fund also employs risk management measures to monitor significant declines in the Fund's NAVPu and alert the Trustee to review current strategies and take corrective action as necessary. The Fund also undergoes an annual review to ensure that it is equipped to fund any redemption requirement in a timely manner and at a reasonable cost during times of financial stress.

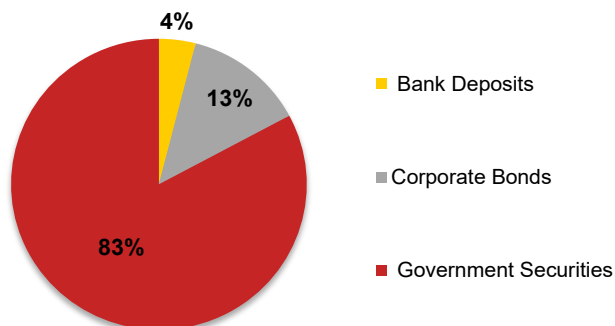

The BPHIL13 Index is a systematically designed, rules-based, market value-weighted index that measures the performance of intermediate-term, fixed-rate local currency securities that are publicly issued by the Philippines. It includes a diversified range of fixed income securities with different coupon rates, maturities of between 1 to 3 years, minimum par amounts of Php3.0Bn, and are traded in the Philippine market. This Index is adjusted for tax by the Trustee, but does not reflect deductions for fees and expenses. Additional information on the benchmark and/or its administrator can be found on Bloomberg, and be made available to investors upon request.

The benchmark provides a standard for evaluating the Fund's performance by helping investors/participants understand how the Fund is performing relative to the market or asset class the Fund represents. The benchmark reflects the performance of peso-denominated fixed income securities with maturities of between 1 to 3 years. Additionally, its characteristics serve as reference point for the Fund's duration and credit positioning.

The Fund has deposits with the Bank Proper, amounting to Php1.15 million, which were approved by the Board of Directors/Trust Investment Committee. Likewise, all related parties transactions are conducted on an arm's length basis.

OUTLOOK AND STRATEGY

Market sentiment remained subdued during the month amid concerns over slowing economic growth, elevated inflation, and persistent geopolitical tensions in the Middle East. First-quarter GDP growth slowed to 2.8%, its weakest pace since the pandemic, as household consumption moderated and investments contracted. Meanwhile, April inflation accelerated to 7.2%, exceeding both market expectations and the BSP's forecast range, driven largely by higher transport and food prices. The Bangko Sentral ng Pilipinas (BSP) expects May inflation to settle at around 6.3%, remaining well above target. Against this backdrop, the BSP signaled

²**Volatility** measures the degree to which the Fund fluctuates vis-à-vis its average return over a period of time. This is computed by getting the standard deviation of the yearly returns for the past 12 mos.

³**Sharpe Ratio** is used to characterize how well the return of a Fund compensates the investor for the level of risk taken. The higher the number, the better. This is computed by dividing the excess return of the fund against the risk-free rate over the fund's volatility.

⁴**Information Ratio** measures the reward-to-risk efficiency of the portfolio relative to the benchmark. The higher the number, the higher the reward per unit of risk. This is computed by dividing the excess return of the fund against the benchmark over the fund's volatility.

the possibility of an off-cycle rate hike ahead of its June 18 policy meeting, following the 25-basis-point increase in April that brought the policy rate to 4.50%. BSP Governor Eli Remolona noted that policy rates may still be behind the curve. On the currency front, the Philippine peso remained weak, ending the month at 61.596 against the US dollar, near record lows. Overseas, diplomatic efforts to extend the ceasefire between the US and Iran continued during the month. However, commercial traffic through the Strait of Hormuz remained well below normal levels, posing ongoing risks to global energy supply and inflation.

Domestic bond yields moved sharply higher in May, with the curve rising by an average of 63 basis points. The 2-year benchmark climbed 77 basis points to 6.82%, while the 10-year yield increased 56 basis points to 7.49%. In the primary market, the Bureau of the Treasury (BTr) saw mixed demand across its auctions, raising Php88.7 billion against its Php120-140 billion funding target. The BTr fully awarded its 3-year bonds at 6.93%, 4-year bonds at 7.43%, 5-year bonds at 7.25%, and 10-year bonds at 7.60%. In contrast, the 20-year offering was only partially awarded at 7.71% as investors demanded higher yields, while the 7-year issuance was rejected outright after bids implied a yield of 7.915%, which the BTr deemed too expensive. Meanwhile, BTr data showed that the country's debt-to-GDP ratio rose to 65.2% as of the first quarter of 2026, up from 63.2% a year earlier. National government debt reached a record Php18.49 trillion, up 10.8% year-on-year, driven by fresh borrowings and peso depreciation.

Looking ahead, the bond market is expected to remain sensitive to macroeconomic and geopolitical developments, as well as to the path of monetary policy. On the supply side, the BTr has programmed up to Php140 billion of issuances across the 3-, 4-, 5-, 7-, 8-, and 10-year tenors, with no additional supply scheduled on the long end of the curve. Against this backdrop, the Fund remains selective in its bond purchases, seeking to enhance portfolio yield while carefully managing duration risk.

INVESTMENT POLICY / PROSPECTIVE INVESTMENTS

The Fund may be invested or reinvested in the following:

- a) Securities issued by or guaranteed by the Philippine government or the Bangko Sentral ng Pilipinas (BSP);
- b) Tradable fixed income securities issued by private and public corporations which are listed and traded in an organized exchange/market such as bonds, notes and preferred shares which are classified as debt securities under appropriate accounting standards;
- c) Deposits and tradable money market instruments issued by local banks, including those of the Trustee's own bank, and foreign banks or their Philippine branches or any financial institution in any foreign country;
- d) Financial derivatives instruments solely for the purpose of hedging risk exposures of the existing investments of the Fund, provided that these are accounted for in accordance with existing BSP hedging guidelines as well as the Trustee's risk management and hedging policies duly approved by the Trust Investment Committee and disclosed to participants; and
- e) Such other tradable investment outlets/categories as the BSP may allow.
