INVESTMENT OBJECTIVE AND STRATEGY

The Chinabank Short-Term Fund intends to achieve a high level of liquidity and better earnings potential than those offered by money market placements, regular savings deposit and short-term time deposit accounts by investing in a diversified portfolio of marketable financial instruments including deposits issued by financial institutions, money market instruments, government securities, BSP securities, corporate bonds/notes with a weighted average portfolio modified duration of not more than one (1) year, and preferred shares classified as debt securities. The Fund aims to outperform its benchmark which is the Bloomberg Philippine Sovereign Bond Index Money Market (BPHILMM Index).

CLIENT SUITABILITY

A client profiling process shall be performed prior to participating in the Fund to guide the prospective investor if the Fund is suited to his/her investment objectives and risk tolerance. Before deciding to invest, clients are advised to read the Declaration of Trust, a copy of which is available at the Trustee's principal office.

The Chinabank Short-Term Fund is suitable only for investors who:

- have a moderate risk appetite;
- are willing to assume a certain level of risk in consideration for higher returns; and
- have an investment horizon of at least one (1) year.

KEY RISKS AND RISK MANAGEMENT

The client should not invest in this Fund if the client does not understand or is not comfortable with the accompanying risks.

- Interest Rate Risk.** This is the possibility for an investor to experience losses due to changes in interest rates. The purchase and sale of a debt instrument may result in profit or loss because the value of a debt instrument changes inversely with prevailing interest rates.



The Fund also employs risk management measures to monitor significant declines in the Fund's NAVPU and alert the Trustee to review current strategies and take corrective action as necessary. The Fund also undergoes an annual review to ensure that it is equipped to fund any redemption requirement in a timely manner and at a reasonable cost during times of financial stress.

NAVPU GRAPH





The BPHILMM Index is a systematically designed, rules-based, market value-weighted index that measures the performance of short-term, fixed-rate and zero-coupon local currency securities that are publicly issued by the Philippines. It includes liquid money market instruments such as treasury bills with maturities of less than 1 year and minimum par amounts of Php3.0Bn. This Index is adjusted for tax by the Trustee, but does not reflect deductions for fees and expenses. Additional information on the benchmark and/or its administrator can be found on Bloomberg, and be made available to investors upon request.

The benchmark provides a reference for evaluating the performance of highly liquid, peso-denominated marketable fixed income securities with a duration of not more than 1 year, which are among the allowable investments of the Fund.

RELATED PARTY TRANSACTIONS

The Fund has deposits with the Bank Proper, amounting to Php52.29 million which were approved by the Board of Directors/Trust Investment Committee. Likewise, all related parties transactions are conducted on an arm's length basis.

OUTLOOK AND STRATEGY

In September, the peso yield curve steepened on the back of expectations of further rate cuts and negative sentiment due to the government's flood control fiasco. Rates in the 3-year tenor and below fell, while the rest of the curve went up. The short-end outperformed, falling by 28 basis points (bps) on average, with the 1-year fetching 5.2595%. Meanwhile, the belly and the long-end rose by 2 and 7 bps, respectively. The 2-year rate fell 5 bps to 5.715% while the 10-year yield fell 2 bps to 6.2763%. Market trading volume was down 0.7% to Php1.616 trillion, with FXTNs comprising 40% or majority of activity, followed by RTBs at 29%.

Headline inflation quickened to 1.5% YoY in August, surpassing expectations but remaining within the BSP's 2-4% target. The rise was mainly driven by typhoon-related food supply disruptions and higher electricity costs, partially offset by a 17% drop in rice prices. Bangko Sentral ng Pilipinas' (BSP) Governor Remolona had said monetary policy remains in a "sweet spot" that balances inflation control and growth support but noted openness to a 25-bp rate cut if economic activity weakens. Meanwhile, unemployment rate jumped to 5.3% in

²**Volatility** measures the degree to which the Fund fluctuates vis-à-vis its average return over a period of time. This is computed by getting the standard deviation of the yearly returns for the past 12 mos.

³**Sharpe Ratio** is used to characterize how well the return of a Fund compensates the investor for the level of risk taken. The higher the number, the better. This is computed by dividing the excess return of the fund against the risk-free rate over the fund's volatility.

⁴**Information Ratio** measures the reward-to-risk efficiency of the portfolio relative to the benchmark. The higher the number, the higher the reward per unit of risk. This is computed by dividing the excess return of the fund against the benchmark over the fund's volatility.

July from 3.7% in June, the highest since June 2022, reflecting seasonal job adjustments, slower hiring in manufacturing and construction, and soft global demand affecting export industries. This increase may dampen household spending in the near term. On a positive note, cash remittances rose 3% YoY to USD3.18 billion in July, the highest in seven months, driven by school-related expenses, a stronger U.S. dollar, and higher deployment of sea-based workers.

In the primary market, the Bureau of the Treasury (BTr) raised Php111.85 billion in bonds and Php122 billion in bills, both met with strong demand. Bill auctions averaged a 5.17x bid-to-cover (BCR) ratio as rates fell 35 bps, while bonds averaged 2.56x with rates down 13 bps. The BTr also announced its Q4 auction schedule of Php35 billion in dual-tranche FXTNs every two weeks, with tenors ranging from 3 to 25 years. Meanwhile, the BSP raised Php374.3 billion in bills, averaging 1.02x BCR, with the 28-day bill rate up 2 bps and the 56-day bill rate down 3 bps versus last month's auction. Against this backdrop, the Fund maintains diversified holdings in BSP bills, government securities, time deposits, and corporate bonds, aiming to balance returns and liquidity as we expect the market to be driven by key macroeconomic data and central bank guidance.

INVESTMENT POLICY / PROSPECTIVE INVESTMENTS

The Fund may be invested or reinvested in the following:

- a) Securities issued by or guaranteed by the Philippine government or the Bangko Sentral ng Pilipinas (BSP);
- b) Tradable fixed income securities issued by private and public corporations which are listed and traded in an organized exchange/market such as bonds, notes and preferred shares which are classified as debt securities under appropriate accounting standards;
- c) Deposits and tradable money market instruments issued by local banks, including those of the Trustee's own bank, and foreign banks or their Philippine branches or any financial institution in any foreign country;
- d) Financial derivatives instruments solely for the purpose of hedging risk exposures of the existing investments of the Fund, provided that these are accounted for in accordance with existing BSP hedging guidelines as well as the Trustee's risk management and hedging policies duly approved by the Trust Investment Committee and disclosed to participants; and
- e) Such other tradable investment outlets/categories as the BSP may allow.
