- 8. Chinabank Philippine Equity Index Tracker Fund
- 9. Chinabank Dollar Cash Fund

We have revised the Plan Rules of the above-mentioned UITFs to implement routine updates for consistency with regulatory requirements as well as align with the Trustee's investment strategies and policies, as applicable.
