Frequently Asked Questions New Check Design Implementation

Guide for CBC Clients

Q1. When does the new check design start?

A: The new check design starts on May 1, 2024.

Q2. What are the Basic Features of the New Check Design?

A: The new check design includes:

- 1. A standard MM-DD-YYYY boxed date format (e.g., 08-16-2023 for August 16, 2023).
- 2. The Peso (₱) sign is moved to the left side of the Amount in figures box.
- 3. The signature box replaces the signature line.

Q3. What happens if I mistakenly use an old check format after May 1, 2024?

A: Your check will not be accepted for deposit and will be returned.

Q4. Can I still use alphanumeric dates on the new check design?

A: No, starting May 1, 2024, only checks with numeric MM-DD-YYYY dates are acceptable.

Q5. Under what conditions will my old format checks still be accepted for clearing?

A:

- 1. If you have post-dated checks stamped or printed with the word "Warehoused" accepted before May 1, 2024.
- 2. If you have Manager's Check/Cashier's Check with the "Waiver Statement."
- 3. If your checks were issued from November 4, 2023, until April 30, 2024, and presented for deposit or encashment within 179 days after the issue date.

Q6. What will happen to my old format CBC checks after May 1, 2024?

A: In general, old format CBC checks are not acceptable for clearing. However, in CBC branches, they will still be accepted for deposit to your own CBC Account or over-the-counter encashment only.

Q7. Do I need to replace already issued post-dated checks (PDCs)?

A: No, if your PDCs have been duly stamped "Warehoused" by the payee's bank before May 1, 2024.

Q8. Do I need to replace checks in the old design that I've already received?

A: In general, old format CBC checks are not acceptable for clearing. However if your outstanding checks with the old design are dated between November 4, 2023, and April 30, 2024, and presented for deposit or encashment within 179 days after the issue date, these are acceptable and need not be replaced.

Q9. Can checks on the new design with printed dates or signature/s that extend beyond the designated box still be accepted?

A: Yes, printed MM-DD-YYYY issue dates and signatures extending beyond the boxed area are valid and acceptable.


Q10. Can I still use old format PDCs kept in my possession?

A: No, only PDCs warehoused by the banks before May 1, 2024, are acceptable.


IMPORTANT REMINDER NEW DESIGN CHECKS

Effective May 1, 2024, only NEW DESIGN CHECKS will be accepted by banks for clearing.

An OLD DESIGN CHECK, such as shown below, will be accepted by banks for clearing only until April 30, 2024

IMPORTANT REMINDER NEW DATE WRITING FORMAT

Effective May 1, 2024, all check dates must be in PURELY NUMERIC FORMAT following this sequence:

MM-DD-YYY
example
05-01-2024

Other separators such as "/" may also be used as long as the sequence is followed.
