## China Bank-SMAC Prestige Membership Terms and Conditions

The SMAC Rewards Program has two types: China Bank-SMAC and China Bank-SMAC Prestige. China Bank has the sole discretion of granting China Bank-SMAC or China Bank-SMAC Prestige Membership depending on the China Bank Credit Card type issued to the Cardholder. The China Bank-SMAC or China Bank-SMAC Prestige Membership is the property of China Bank

## 1. China Bank-SMAC Prestige Membership General Terms and Conditions

- 1.1. The China Bank-SMAC Prestige is exclusive to China Bank World Mastercard and China Bank Wealth Mastercard Principal Cardholders who have opted in the China Bank-SMAC Prestige Membership.
- 1.2. The Principal Cardholder will be granted a complimentary China Bank-SMAC Prestige upon opting in and meeting the required minimum spend of Php50,000 using his/her China Bank Credit Card. The Principal Cardholder should ensure that his/her information or personal file is up to date by reporting any change in name, address, mobile number, e-mail address, and other pertinent data to ensure receipt of notices and proper handling of any China Bank-SMAC Prestige Card concerns. - 1.6. In the event of credit card downgrade, upgrade, or conversion, resulting to change in the card type of the Principal Cardholder's China Bank Credit Card, his/her China Bank-SMAC Prestige Membership will be: 1.6.1. Transferred to the new China Bank Credit Card type if it has the same benefit.
  - 1.6.2. Cancelled if the new China Bank Credit Card type does not have the same benefit. The Principal Cardholder is encouraged to redeem any unused SMAC Points prior to card conversion request. Unredeemed SMAC Points, Awards, or Privileges will be forfeited.
- 1.7. Renewal of the China Bank-SMAC Prestige Membership is contingent to the renewal of the China Bank Credit Card. Eligible Principal Cardholders shall be sent an SMS or e-mail advisory on how to opt in to renew the China Bank-SMAC Prestige Card. - 1.11. Applicable replacement/renewal fees shall be charged to the Credit Card Account upon request for the replacement/renewal by the Principal Cardholder.
- 1.12. China Bank reserves the right to revoke the China Bank-SMAC Prestige Membership for any reason it deems appropriate with notice to the Cardholder.
- 1.13. China Bank reserves the right to change any part of these Terms and Conditions, such as but not limited to applicable fees, with notice to the Cardholder.
- 1.14. Any requests for replacement or renewal of the China Bank-SMAC Prestige Card should only be coursed through the China Bank Customer Service Hotline.
- 1.15. The China Bank-SMAC Prestige Membership shall also be governed by the general terms and conditions of <a href="SMAC">SMAC</a> not inconsistent with China Bank-SMAC Prestige Membership Terms and Conditions.
